Dear Sir: -

I have the honor to reply to your letter 306-11B of the 28th, October, regarding attempted suicide of Kenneth Stonechild, pupil of the File Hills Indian Residential School.

I attach herewith statement from Mr. Rhodes, Principal of the School also statement from Mr. Ganner, Boys Supervisor.

At about 9 A.M. Sunday Octr. 22nd, Mr. Rhodes, came to my home and informed me that a boy Kenneth Stonechild truanted from the School at about 5.30 P.M. fast time, Saturday Octr. 21st. He also informed me that the Father of the boy and the boy arrived at the School at 8.15 Sunday morning. The father stated that he had found his son Kenneth hanging by the neck from a cross beam in his stable at approximately ten minutes to seven.

Mr. Rhodes and I went to the home and stable of Harry Stonechild, father of the boy, and we inspected the rope in the stable, and found that it had been cut. We also found that the knot of the rope was still quite loose. While we were in the stable Harry Stonechild came over from the house and explained to us just how he had found Kenneth hanging. He also explained that he had cut the rope and assisted Kenneth over to the house. We then proceeded to the house and I questioned Kenneth and examined him for marks in the vacinity of the neck. I found a very slight abraision running along the point of the jawbone. Kenneth informed me that he had run away from the school because he had been sent back on the playground by one of the members of Staff, also that he "thought" the member had said he would attend to him later. He also informed me that he had obtained the rope used, from the bran room in the barn. I then returned to the Agency and immediately called Dr. Simes the Medical officer and the R.C.M.P. at Balcarres requesting them to come out and make an examination and investigation. I presume reports in full have been submitted to you from the Doctor and Police.

I would like to point out however the fact that the rope knot was quite loose indicating that no great strain had been placed upon it, further the beam from which the rope was suspended was quite low and that in my opinion it was impossible for a person of this boys height to hang suspended from this rope. Another fact which would require some explaining is that while this boy was cut down at 6.50 A.M. yet he and his father returned to the school at 8.15 A.M. and the place where the deed was done is some 20 to 25 minutes walk from the school, which would indicate the boy had not suffered much physicial strain.

While Mr. Rhodes opinion is that this boy was trying to bring discredit to the school, my opinion is that the boy wanted away from the school for good, also Mr. Rhodes informed me afterwards that the parents of this boy had made a verbal request last spring for the discharge of Kenneth.

Re: No 179 Kenneth Stonechild.

In accordance with Dr Robertson's request in his letter dated October 28th relative to the attempted suicide of the above mentioned Pupil of this School, herewith please find statement from myself and one from Mr Ganner, Boys Supervisor, attached.

It was reported to me at about 6-25 PM on Saturday October 21st that the above mentioned Pupil was absent from the Supper Table, I instructed the Farm Instructor and the Boys Supervisor to search the grounds and Buildings for him, this was done but they were unsuccessful in finding the boy, I then proceeded to the home of the Boys Parents, Mr Harry Stonechild, and informed them that the Boy had left the School without permission, Mr Stonechild immediately commenced a search for his Son and on my way back to the School I kept a sharp watch for any trace of the Boy.

On my return to the School I made enquiries of the male members of Staff to ascertain if there was any real cause for the boy running away, Mr Ganner gave the information as set out in his statement, this information was corroborated on questioning the Boy the following day and it would appear that his truancy and subsequent act were based on the flimsiest of causes, this Boy had not been punished and as far as I am aware there had not been any threatened punishment by any of the members of Staff.

This Boy is at times very vacant and while I have never noticed any suicidal tendencies there appears to be rather a low mentality, I believe however that there was not any premeditated intention of committing suicide but rather a desire to cause trouble or bring discredit on the School.



On the afternoon of Oct. 212 at 4. P. m in my capacity as Boys Supervisor I was in the yard when I saw Kenneth Stonechild Chimbring through the play ground fence and proceed towards the Horse- Bane.

according to the Rules of the School as laid down by the Principal the aleve pupil was

- 1) Going over or through the play ground fence to get to the Barn- yard.
- D'Young to the Horse. Barn 45 minutes before the proper time for evening choses withour authority of the farm instructor.

I accordingly called to the Born from the

and asked him where he was going-

Die informed me he was going to the Horse Barn to feed-up.


I asked him if the fame Instructor Rad told him to do so, and he said. No.

I then told him to get back into the play-ground (by the proper way) and stay there until the farm instructor called him for chores_

I was at least 25 yards from the pupil during the conversation.

I subsequently Reard that Neuneth Stonechied went to chores at the proper time, but at assembly for supper et. 5.30. I'm he was missing. When the opportunity occurred I informed the Principal of his absence.

I also wish to state emphalically that I did not punish thus pupile in any way whatsoever - nor did I threaten to do so.

Dear Doctor Robertson:

Re: Kenneth Stonechild, Pupil File Hills School.

I beg to acknowledge receipt of your letter file 306-11B., dated November 8, requesting report on the above named Indian School boy.

Since his admission to hospital for observation following which was thought to be an attempt to commit suicide, he has appeared to be perfectly normal and in no way has exhibited any symptoms of mental disarrangement. In order to be certain he was normal it will be necessary to to take him in for examination and report by Dr. Rothwell. I am hoping that it will not be necessary for him to remain in Hospital, but expect to take him to the Doctor's office. Once this report is received a report will be forwarded to you.

At present I am of the opinion that the action he took was not that he wished to take his own life, but rather that he wished to stir up disatisfaction against the school and staff, with the hope that he would be discharged. Unless Dr. Rothwell recommends that he be committed to a mental institution, I would recommend that arrangements be made for him to be transferred to another Residential School. I do not feel that it would be in the best interests of the other pupils to have him back at File Hills School and there would be a certain amount of punishment, that he is going to be away from his parents and not be able to see them as frequently as in the past. To me there is no reason whyhe should not continue to attend school. I will admit that no matter how long he may go he never will win a Governor General's medal, but that is no excuse to allow him to return to the Reserve to bum around and do nothing. If he is wanting to start that before he is 15 years of age, what will be be like when he reaches the age of 25 years.

In reference to the above, phone call was received from Geo Dodds, Indian Agent at 10.40 a,m, this date to the effect that the above mentioned had attempted to take his life by hanging, this a, m, he had been out down in time by his father Harry Stonechild, and was not apparently O.K. at his home.

I patrolled per riv Auto to The Agency and the School, in charge of Principal, Mr.F.Rhodes, who was interviewed, Mr Dodds being away from the Reserve, Mr Rhodes stated that the above mentioned ran away from the school at 5.30 p,m, on the 21st inst, a search was made by Mr Rhodes and assistants but boy was not located, he was brought back to the school by his father at 8.15 a.m. date, on October Ist. 1939, he was weighed at 106 lbs. he is I4 years and 8 months of age, birthdate March. Ist. 25.

Dr A.B. Symes, arrived at the Reserve and I patrolled with him to the residence of Harry Stonechild, where an examination was made of the barn in which the attempt was made, same is a log building 8'X IO', floor to roof, 7' there was a piece of rope hanging from a log downwards

> I was at school on Saturday, I ran away from school when the bell rang for washing(5.30 p,m,) I went to my grandmothers, I went to the house my grandmother was home, I told her I ransway from school, she went to Alex Stonechilds, I stayed in the house I was dark already, I stayed there about half an hour, I then came over to my Dads stable. I stayed around the stable I did not sleep. I stayed outside the stable, when it was breaking day I went into the stable, there were three horses in the stable, I had a rope that I had brought from the school in my hand. I put the rope around my neck, after putting it over a log in the barn, I wrapped the rope around my neck three times, I was trying to hang myself, I was hanging for half an hour. then Wilmer came in, then my Dad came he caught me and cut the rope and helped me out of the barn.

He brought me to the house, I was feeling sick, I sat on a chair for a while, I had breakfast, I ate porridge milk, bread and butter. I went upstairs to bed, then Mr Rhodes and Mr Dodds came, they asked me questiones, before Mr Rhodes and Mr Dodds came I had walked to the school with Diary Date set for my Dad. I did this that is try to hang myself, because I did not like the way the staff at the school acted.

STATEMENT OF HARRY STONECHILD, Indian.

" I am the father of Kenneth Stonechild, in July. 1939 when Kenneth was on holidays he went away, this was on Balcarres Sports Day, he did not let us know, he went to Fort Qu'Appelle, he came home by himself.

He wants to leave the school complaining that he cannot hear and it was causing trouble between him and the staff, having been notified that Kenneth had runaway from school last night, I looked for him, about 6.50 a.m. this date when I went to the barn I found Kenneth hanging by a rope from a rafter in my stable, I felt his heart and cut him down, he was 0.K. we had breakfast then I took Kenneth up to the school, we walked up. I do not know any reason for him doing this.

of Stonechilds, he is crippled and a mute, this lad manneth was taken to the barn and described how he was hanging, he had the rope around his neck three times, the feet were spread on the floor, and he was lying back in the rope, pressure on the back of his neak, he would have starved to death before he would have died from hanging.

abrasions on the neck and cheeks, The Doctor stated he would take this lad to The Hospital at Fort qu'appelle, Sask, and keep him under observation considering he was physopathic, and in view of this lade age etc, and the fact that he was an Indian, and Juvenile, this appeared to be correct prodeedure, as this lad does not appear responsible for his actions.

Dear Sir:

I beg to attach Police Report and correspondence re Kenneth Stonechild, attempted suicide, File Hills Residential School.

It will be noted the Police suggest that some further investigation should be made into the cause for his act. I have taken the matter up with Mr. Dodds, the Agent; Mr. Rhodes, the Principal of the School; and Dr. Simes, our Medical Superintendent. I can find no evidence that this boy has received any punishment in the past, had anything to fear at that time, or any valid reason why he should have made this attempt.

The boy has been, since that date, in the Qu'Appelle Indian Hospital, under the supervision of Dr. Simes, and the Doctor reports that he can find no evidence of any mental derangement. He is, however, going to bring him in to Dr. Rothwell for further examination. It is also Dr. Simes' opinion that the act was not committed with the intention of taking his life, but rather to stir up trouble in the school in the hope of securing his discharge. Dr. Simes recommends that if the boy is found to be normal he be returned to another school. as he considers the boy would have a bad influence, if he were returned there, on the rest of the pupils. Dr. Simes is apparently also of the opinion that he is not very bright and the schooling will not be of much benefit to him, but considers that he would be better there than running around the reserve.

We have in our schools both boys and girls around 15 years of age upon whom, in my opinion, we are simply squandering money in continuing them there with the hope of advancing them further in education. This boy is apparently one of that class. Under ordinary conditions I would recommend his discharge, but owing to the fact that it is believed he took this action for the purpose of obtaining his discharge, were it now given, it would have a tendency to encourage other pupils to take some action such as this to obtain theirs. I would therefore recommend that if this boy be found normal, authority be given to transfer him to another school. May I have your instructions please.

P.S .-- Since writing the above, I am in receipt of another letter from Dr. Simes in which he states that Dr. Rothwell can find no evidence of mental derangement but recommends the boy be transferred to another school rather than sent back to File Hills. I might also state that I have advised the Police I can find no reason for this boy's action except a desire to obtain his discharge from the school.

November 17 and also a police report relating to the above noted student, attached thereto.

I note that in the last paragraph of your letter you state: "We have in our schools both boys and girls around 15 years of age upon whom in my opinion we are simply squandering money in continuing them there with the hope of advancing them further in education."

I am inclined to agree with you that a great deal of time is wasted in all educational institutions in seeking to educate boys and girls with a low I. Q. On the other hand, we have learned from experience that it is an exceedingly dangerous thing to turn boys and girls of this age with a low I. Q. rating loose on the reserves. You should feel perfectly free to point out to the principals of residential schools that these boys and girls should be engaged in vocational work - sewing, knitting, mat making, basketry, elementary agriculture, dish washing, etc. I learned from experience in the operation of the subnormal institution at Portage that it is astonishing what these boys and girls can undertake and accomplish if given the right direction.

In the case of Kenneth Stonechild, I can

see no -

see no serious objection to his transfer to another school, provided you can make the necessary arrangements. If, on the other hand, home conditions are reasonably satisfactory, he might be allowed to return home. The history of the attempted suicide is likely to reach the school ahead of him and make it somewhat embarrassing for him to feel at home in any school to which he might be sent. Any arrangements you can see fit to make will be acceptable to the Department.

Dear Dr. Simes:

Your patient, Stonechild, was in my office on November 14th. After going into this case, and with the information you had given me, I feel that it is just a problem of behaviour in this boy. It might seem a little unusual that he would go to the lengths of trying to take his life, but I feel, as you seem to, that he did not intend to do anything more than create sympathy for himself. He is undoubtedly deaf and has considerable difficulty in the school classroom, and as a result of this he claims that the teacher would get out of patience with him at times and "Boxed his ears", I believe he said. He is quite emotional and cried, when telling about it. I suppose that it was not as bad as that, but rather he himself was not anxious to remain in school. No doubt these children of the wild are even more inclined to want to be out of School in the wide open spaces than a white child, so it would not be very unusual if he did feel that way about school.

When he left the school and went home he was still in fear of his father punishing him and taking him back to the school, and that no doubt would explain his remaining outside and then arranging things so that it would appear when they turned up in the morning that he had tried to take his own life. He is only fifteen years of age and rather young to think of something as serious as that, and I do not feel that he was intending to take his own life—in fact he volunteers the statement now that he did not, but thought it would be a good way to have himself excused from running way from school.

I am inclined to be sympathetic towards this youngster because there were many things about the school that he did not like besides the teacher. He tells me that the boys of his age teased him a great deal and would tell him he was both dumb and deaf and, from his own statements, they did impose upon him. To protect himself from that he chose to play with children much younger, which no doubt created the impression among the teachers that he was of their mental age.

You suggest getting some new school environment and I think that would be advisable and it might ship to solve the problem. I do not feel that this boy is as yet either a defective or a case of mental trouble.

Pupil of this School truanted on Friday evening, November 17th between 5-30 and 6-00 PM, he proceeded to his home the same evening, I went to the home of his Parents the following morning and they informed me that the boy was out helping his brothers to cut wood, when the Father and myself went to the bluff the boy could not be found, I decided to leave the boy with his Parents and advised them to bring him back to the School when he had settled down somewhat, they returned him to the School on Tuesday afternoon and at 5-30 the same evening he was again missing he was returned to the School again on Thursday and was put to bed and his clothing taken away from him.

Then tries to

commit suicide

Boy keeps running

home, finally take his clothes away

On Friday morning Mr Ganner, the Boys Supervisor sent one of the Boys to the Dormitory for this boys dishes, the boy returned immediately and reported that Reggie was trying to hang himself in the Bathroom in the Dormitory, Mr Ganner immediately went to the Dormitory and found this Boy suspended from a vent pipe in the Bathroom by a belt under his chin and attached to a Bed sheet thrown over the pipe, Mr Ganner released the boy and sent him back to his bed, (the boy was able to walk to his bed without any difficulty) and placed a guard over him, this guard has been maintained since.

Staff are mean and pick on him

On Saturday on my return I notified the Mounted Police at Balcarres of this incident and he made a trip to the School for the purpose of questioning this Boy, we were not able to glean any information as to why he had done this other than that the Staff are always mean to him and are always picking on him, this has been the excuse given in other cases

the reason for running away, I would say that this boy like kenneth Stonechild has not been disciplined or punished, and they therefore cannot give this as a cause for their truancy, they resent being spoken to and corrected by the members of Staff, that is the only reason we can find for their actions.

It would appear upon questioning that this Boy did not actually intend to do away with himself, it is significant that he waited until he heard some-one coming to the Dormitory and then made the attempt knowing that they would immediately look for him when they found that he was not in his bed, he has admitted to me since that it was not his intention to go the limit, that he wanted to cause trouble by this action, I believe there is a concerted effort afoot to cause trouble and bring discredit upon the School and the Staff, particularly Mr Ganner, it has always been my experience that one member of Staff is particularly disliked by the Indians and they will go to any length to cause trouble for him in the hope that he will be discharged, when they succeed in their efforts they direct their attentions to another member of Staff, in past years this attitude has been igmored by myself and I have told the Indians that I will take the responsibility for my Staff, and that I would not tolerate any interference on their part, I still believe that these boys have been put up to this by some-one outside, but neither the Mounted Police Corporal or myself have been successful in finding out who it is.

In this connection I have been thinking that it might be as well if we were to ask the Mounted Police to co-operate and send a special investigator to the School, I would be willing to give Mr Ganner extended leave of absence, and the investigator could take Mr Ganner's position at the School, we could leave the impression that Mr Ganner had resigned and left, this arrangement would have to be entirely secret of course, I wonder if you could see the Mounted action would help to clear up this matter) I am firmly convinced that this is the only way we can get to the bottom of the affair.

In connection with the Kenneth Stonechild case: I am quoting a few extracts from a short letter I received from Mr Frayling of the Gordon's School on Saturday, his letter is dated the 23rd.

"Dear Mr Rhodes,

of one of your boy pupils, *** You have my sympathy at such times."

It would appear from the above that reports have been circulated among the Indians of the Touchwood Agency that Stonechild actually took his life, I have not heard where Mr Frayling got his information, but there is no doubt that what he has heard is quite

accepted as true on that Agency, I do not know just how general the circulation of this report has been, but there is no doubt that the whole Province, (at least the Indians of the Province) are aware of the attempt made by Stonechild, I would therefore like you to co-operate with me and forward a letter to the Indian Agent at the Touchwood Agency stating that the reports circulated throughout that Agency are entirely untrue and requesting the Agent to correct this impression in his contacts with the Indians, it might be that we shall hear of similar reports from other Agencies and it might then be necessary to circulate all Agencies that these reports are absolutley untrue.

Verbally in your Office I would be willing to come in and do so, at the present time I feel that one can hardly leave the place in case something else crops up that will have more disastrous effects.

I trust you will be able to give this matter your early attention.

Two suicide attempts

Dear Sir:

Re: File Hills Indian Residential School.

I am attaching a letter received from Mr. Rhodes, Principal of the above school. You will note from this that there has been another case of so-called attempted suicide at this school; that it is Mr. Rhodes' opinion that there is some outside influence trying to stir up trouble; that he suggests getting the Mounted Police to send in a special investigator.

I have discussed the matter thoroughly with Mr. Rhodes. He is firmly convinced that in neither case did the boys actually intend to commit suicide--in fact both of them have admitted that they did not. In the last case the strap was under the boy's chin, not around his throat.

Mr. Rhodes is of the opinion that while the Boys' Supervisor, Mr. Ganner, has done nothing in the way of punishment to antagonize the boys, some of them have taken a dislike to him and are adopting this method of stirring up trouble, with the hope of having him removed. While Mr. Rhodes suspects some outside influence is at work, he has no evidence at all to support the idea.

He suggested that the Police send in an investigator, and while, in my opinion, to do so would be of no value, as I do not believe the Indians would give any information to any white man so sent in, even if outside influence is being used, I took the matter up with the Mounted Police and they advise that while they are at all times
